

Mission Statement

LegalCORPS expands access to business law services for low-income individuals and organizations to promote economic development and strengthen communities. As Minnesota's only business law legal aid organization, LegalCORPS programs empower individuals and families to build noble legacies for generations to come.

Our Attorneys

We accomplish our mission through the services of primarily volunteer business and intellectual property law attorneys. We have one part-time staff attorney. LegalCORPS has over 550 volunteer attorneys on our roster, and we serve over 1800 clients annually. Attorneys volunteer for various personal and professional reasons — but a unifying motivation is Rule 6.1 of the Rules of Professional Conduct, which expresses the legal profession's aspiration to serve those in the community who cannot afford legal services on their own.

Pro bono legal assistance is the kind of volunteer community service only attorneys can provide.

Positive Impact on Communities

Sound guidance on business law matters is essential to the success of any venture, both for-profit and nonprofit entities. This is preventative legal support, and while receiving front-end guidance won't guarantee freedom from legal concerns down the line, we aim to reduce the likelihood. The success of the small businesses and nonprofit organizations that our clients start is essential to not only their personal financial stability but also to the economic vitality of all of Minnesota. LegalCORPS programs are designed to help make all of Minnesota's communities great places to live, raise families, do business, and serve others.

ENTREPRENEURS OF COLOR PROGRAM

The Entrepreneurs of Color Program is a LegalCORPS initiative to make business law services more accessible to recent immigrants and Black/Indigenous/People of Color.

We partner with community-based organizations that have built trusting relationships with historically marginalized populations who then refer these clients to LegalCORPS when appropriate.






Legal Advice

INVENTOR ASSISTANCE PROGRAM

The LegalCORPS Inventor Assistance Program allows inventors with great ideas to overcome one of the financial roadblocks to bringing innovations to market.

Leadership

LegalCORPS started the Inventor Assistance Program, the first and longest-running patent pro bono program in the United States. Based on our model, the U.S. Patent & Trademark Office (USPTO) created a nationwide patent pro bono program.



Legal Advice

We provide free legal representation to qualifying low-income inventors in Minnesota, Wisconsin, lowa, North Dakota and South Dakota who are seeking to patent their inventions. We help inventors through the process by providing an array of services for people who are just beginning to those who are further along in their journey to filing.


