We advocate for economic justice, believing that prosperity and equity are intertwined. Economic security is a necessary baseline for people to survive and thrive, especially amidst conditions of rising inequality. Recognizing economic security as vital for individuals to thrive, LegalCORPS works to mitigate economic precarity, helping individuals secure a stable future. By providing equitable access to business legal services, the agency enables individuals to innovate, start businesses, and launch nonprofits, thereby contributing to job creation, increasing the tax base, and generating generational wealth in underrepresented innovators who have not been able to participate in the American dream due to historical artificial barriers to contribution. Justice looks like over \$1.5 million invested through 3,930 hours of pro bono legal services to small businesses, small nonprofits, and inventors to strengthen their financial stability and build generational wealth. In the past year, LegalCORPS responded to over 2600 inquires and directly served 1,800+ individuals of which 66% of founders were female, 60% were people of color and 80+% fall at or below the 200% of poverty level.
